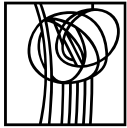
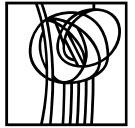

Possible Rat Issues Due to Waterline Work

As noted in our April *Park Bulletin*, Baltimore County Department of Public Works (DPW) has been cleaning water lines and relining them on Milford Mill and upper Adana Rds. Work has begun or will soon begin on Olmstead, McHenry, Kingston and the full length of Adana.

The contractor is digging 6' by 6' holes about every 500 feet to access the water lines. An unintended and unfortunate consequence is that in some of the areas where the project is underway, the digging and underground work has displaced rats, which have been sighted in broad daylight (*sometimes in packs of 7 to 15*) as they searched for new quarters and food. **Fortunately, no additional reports of rats have been received in the last several weeks, but it is important that we remain alert throughout the remainder of the project.**

No one likes rats and we have had many communications with the county about this. Some municipalities require project contractors to use rat abatement procedures when there are major digging projects; Baltimore County does not. However, DPW is making some project changes that will hopefully solve the problem.

In Baltimore County, it is up to individual homeowners to address rodent issues and take measures to prevent, control or eradicate rats. This link, www.baltimorecountymd.gov/Agencies/permits/ridrats/index.html, is to the county's Rid Rats program will give you information about what to do to prevent rats generally; it is very important to put garbage out only in cans with tight lids and not to have food for birds, squirrels or pets outside, especially for the duration of this project.

We hope that the steps DPW is taking will resolve any problems and that rodents will not be an issue for the remainder of the project, but if problems arise, please take the following steps:

1. Carefully read and follow the information about preventative measures at the above county link.

3. Email Jill Savage, Co-President of the community association, if you observe or have difficulty with rat problems during this water lining project. This will help your association to stay informed, gauge the extent of any problem in the neighborhood and continue to work with the county to resolve any problems: jmrcsavage@comcast.net

We want to stress that there may be no additional rodent issues, but we feel it better for residents to have this information and not need it than to become alarmed or delay necessary action if the problem arises.

Include your complete name, address, zip code and a request to “activate the preference service.” For up to five years, this will stop mail from all member organizations that you have not specifically ordered products from.

It offers two types of service options to stop marketing companies from sending you junk mail that you just end up throwing out. Or save yourself some time and sign-up for the premium service (*for a one-time \$20 fee*) and let GreenDimes do all the work of the basic service for you.

Entranceway Project Completed

Baltimore County's Department of Public Works (DPW) and Office of Community Conservation completed our Entranceway Project – including roads, edge treatment and tree planting – in July. This project brings the entranceway back to its pre-rapid transit road width and will recreate the beautiful tree canopy we once had when the trees mature.

We will keep you informed as plans materialize. Until then, please drive the speed limit through the entranceway and the entire community. Thanks!

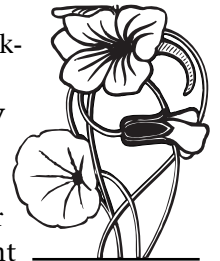

Cool Tips for Saving Energy

While the worst of the heat is probably over, these are still good tips to follow each summer to save energy *and* money.

- Have a professional perform routine maintenance on your heat pump or central air conditioning unit, and have any problems repaired right away
- Change or replace air filters monthly.
- If you have central air conditioning, for every degree you raise your thermostat setting above 72°F, you will save about 5-7% on cooling costs. Set the thermostat at 78°F or higher during the summer months.
- Close blinds during the day to block heat, and open them at night to let heat escape.
- Consider using fans, which use much less power, as an alternative to an air conditioner.
